STATE AGENCIES CREATED, ABOLISHED, OR REVISED BY 2001 WISCONSIN ACT 16

The biennial state budget act (2001 Wisconsin Act 16), passed by the legislature and signed by Governor Scott McCallum on August 30, 2001, creates, abolishes, or revises a variety of state agencies.

15.157(3)	Dwelling Code Council in the Department of Commerce. One member added to represent remodeling contractors who remodel one- and two-family housing.
15.157(8)	Rural Health Development Council in the Department of Commerce. Two members added, one each to represent licensed dentists and licensed dental hygienists.
15.195 (5)	Adolescent Pregnancy Prevention and Pregnancy Services Board , formerly attached to the Department of Health and Family Services, renumbered to s. 15.105(11) and attached to the Department of Administration under s. 15.03.
15.225(2)(b)	Wisconsin Conservation Corps Board attached to the Department of Workforce Development under s. 15.03. Membership revised to specify that the one member from a local workforce development board may be either a board member or employee of that board.
15.225(3)(b)6	Governor's Work-Based Learning Board in the Department of Workforce Development. Membership revised to allow the governor to designate the division administrator from DWD who will serve on the board, replacing the requirement that the administrator of the repealed Division of Workforce Excellence be the board member.
15.915(6)(b)	Environmental Education Board attached to the University of Wisconsin System under s. 15.03. Membership revised to add two members, one representing forestry and the second representing the energy industry.
