### EXTENDED TERMS FOR LEGISLATORS AND COUNTY OFFICERS

In recent years, every session of the Wisconsin Legislature has included constitutional amendment proposals to extend the terms of various legislative or county officials, but the history of such attempts dates back to the early years of the century.

At least as early as 1911, amendment resolutions were introduced in the legislature to extend assembly terms from two to four years. Some would have staggered the election of the assembly members; some included provisions to increase senate terms from four to six years. County officers have sought to have their terms extended from two to four years since the 1920s. Both groups were most optimistic after the Wisconsin Constitution was amended in 1967 to create four-year terms for the statewide offices of governor, lieutenant governor, secretary of state, treasurer and attorney general, effective 1971.

Because the terms of state legislators and elected county officers are prescribed in the Wisconsin Constitution, any change requires a specific constitutional amendment. Article VI, Section 4, of the Wisconsin Constitution specifically includes the county offices of sheriff, coroner, district attorney and register of deeds in the two-year limit, but any elective county office created by the legislature, such as county surveyor, would be covered by the limit.

The major argument for extended terms has been the contention that shorter terms require too much time and money for campaigning, and they hinder the official in fulfilling the policy and administrative duties of the office. An accompanying argument is that these offices ought not be elective at all but should be filled by appointment. To a limited extent, the Wisconsin voters have recognized this in the case of the county coroner which was abolished in favor of an appointed medical examiner by constitutional amendment in counties over 500,000 population (Milwaukee County) in 1965. (A 1972 amendment made the change to a medical examiner system an option in all other counties.) Proposals to make elective county offices appointive have not been as common in recent years.

Those opposed to longer terms of office have argued that the election of officials at shorter intervals makes them more responsive to the people, which some consider especially important with regard to sheriffs.

The attached chart shows the history of constitutional amendment proposals from the 1971 legislative session through the 1993 session. The amendment process requires that the constitutional change must be passed in the form of a joint resolution by two successive legislatures and ratified by the electorate in a statewide election. The constitutional rewording contained in the two joint resolutions must be identical. A total of 17 senate joint resolutions and 29 assembly joint resolutions have been introduced, but none has ever passed both houses on first consideration. The majority of these proposals have dealt with county officers (20) or sheriffs specifically (18). Ten related to the assembly or to both the senate and assembly.
