The published Wisconsin Statutes, issued biennially, are identified by the year in which the Legislature which enacted the most recent legislation convened. Thus, the current edition - for use in the calendar years 1979 and 1980 - is designated the "1977" edition because it incorporates all laws enacted by the 1977 Legislature, which met from January 3, 1977, to January 1, 1979, enacting 451 laws.

Some state agencies reprint in pamphlet form those chapters of the statutes which pertain to their functions. Table I lists chapters which are reprinted and the agencies which have authorized the reprint. Table II lists state agencies and their addresses together with chapters reprinted and their subject matter and price.
