Dear Senator Darling and Representative Nygren:

Enclosed, please find the 2016 Entitlements and Recommended Payments under the Municipal Services Payments Program (MSP), as required under s. 70.119.

The Department submits this payment summary report for municipal services provided during calendar year 2015 as required under s. 70.119 (6). The report shows the entitlements as derived by applying the MSP formula, program adjustments and the payments calculated by the Department of Administration, as required by s. 70.119, Wisconsin Statutes.

The number of towns, villages and cities eligible for payment is 326. The recommended payments are 37.95 percent of the total entitlements. The reduction is necessary to contain the program within its \$ 18,584,200 appropriation. The reduction of payments on a pro-rata basis is a standard action required by s. 70.119 whenever the appropriation is insufficient.
